



**BLUE WATER SAILING MAGAZINE & SUNSAIL CHARTERS • CARIBBEAN CHARTER SWEEPSTAKES OFFICIAL RULES**

1. **ELIGIBILITY:** Open to legal residents of the 50 United States and District of Columbia, 18 years of age and older. (1) **Grand Prize:** a 7 day/6 night charter on a 36' Sunsail yacht in Tortola, British Virgin Islands. Prize does not include, air fares, food provisions, airport transfers, or spending money. All expenses not listed are the sole responsibility of winner. Approximate retail value of prize up to \$3900. Actual value will be determined by seasonal rates. Any difference between actual value and stated value will not be awarded. Charter dates are subject to availability; certain restrictions and blackout dates, which include 12/15/09 through 1/3/10, apply. Trip must be taken by 3/31/2010 or prize will be forfeited in its entirety. Travelers are personally responsible for securing all required government travel documents and any travel insurance, and for compliance with airport/travel security requirements. Winner will be required to submit a boating experience resume on the basis of which Sunsail will determine, in its sole discretion, whether the services of a skipper are required. If so, winner will be required to pay for such services, which are estimated to be in the range of \$180 - \$200 per day.
